Section: Federal Requirements	
Item	Rating
FR1: Includes goals for nutrition education that are designed to promote student wellness.	
FR2: Assures compliance with USDA nutrition standards for reimbursable school meals.	
FR3: District takes steps to protect the privacy of students who qualify for free or reduced priced meals.	
FR4: Free drinking water is available during meals.	
FR5: Ensures annual training for food and nutrition services staff in accordance with USDA Professional Standards.	
FR6: Addresses compliance with USDA nutrition standards (commonly referred to as Smart Snacks) for all food and beverages sold to students during the school day.	
FR7: Regulates food and beverages sold in a la carte.	
FR8: Regulates food and beverages sold in vending machines.	
FR9: Regulates food and beverages sold in school stores.	
FR10: Addresses fundraising with food to be consumed during the school day.	
FR11: Regulates food and beverages <u>served</u> at class parties and other school celebrations in elementary schools. Use N/A if no elementary schools in district.	
FR12: Restricts marketing on the school campus during the school day to only those foods and beverages that meet Smart Snacks standards.	
FR13: Addresses how all relevant groups will participate in the development, implementation, and periodic review and update of the local wellness policy.	
FR14: Identifies the officials responsible for the implementation and compliance of the local wellness policy.	
FR15: Addresses making the wellness policy available to the public.	
FR16: Addresses the assessment of district implementation of the local wellness policy at least once every three years.	
FR17: Addresses making triennial assessment results available to the public and specifies what will be included.	
FR18: Addresses a plan for updating policy based on results of the triennial assessment.

HE4: Addresses alignment between health education curriculum goals and the health needs of students in the community.	
HE5: Addresses opportunities for interdisciplinary connections and practicing health-related skills outside of health education classes.	
HE6: Addresses National Health Education Standards (NHES).	
HE7: Incorporates the CDC's characteristics of an effective health education curriculum.	
HE8: Specifies that health education curriculum will be evaluated and revised.	
NE1: Nutrition education teaches skills that are behavior focused, interactive, and/or participatory.

PEPA15: Joint or shared-use agreements for physical activity participation at all schools.	
PEPA16: District addresses active transport (Safe Routes to School) for all K-12 students who live within walkable/bikeable distance.	
PEPA17: Addresses using physical activity as a reward.	
PEPA18: Addresses physical activity not being used as a punishment.	
PEPA19: Addresses physical activity not being withheld as a punishment.

FE8: Addresses sharing wellness-related information with families.	
FE9: Recommends that school-based volunteer opportunities be provided for families.

HS4: Addresses engagement of and communication with families to address individual student health needs.	
HS5: Specifies opportunities for dissemination of health information resources to students and families (e.g., pamphlets, flyers, posters).	
HS6: Addresses student physical health screenings (e.g., vision, hearing).	
HS7: Addresses assessment and planning for chronic disease management to meet individual student needs (e.g., asthma, diabetes, etc).	
HS8: Addresses management of allergies in the school environment.	
HS9: Addresses provision of acute and emergency care.	
HS10: Specifies a health services plan for response to student sexual risk behavior (e.g. HIV/STD, pregnancy).	
HS11: Specifies a health services plan for response to student substance use (e.g., tobacco, alcohol, illicit substances).

SE12: Specifies a crisis preparedness and response plan.	
SE13: Addresses training for school resource officers in district buildings (if applicable).
